A group of local residents is trying to fight proposals to amend the proposed housing development to industrial units on the land behind Blackburn Road. The resident have concerns regarding the scale and design of the proposed units.

23/00634/LBC Application for listed building consent for the renovation of existing derelict farmhouse, attached barn and dwelling, including single storey extensions at, Lower House Fold Farm, Trigg Lane, Chapel Lane

23/00635/FULHH Single storey rear extension and new pitched roof to replace existing flat roof at 11 Kenyon Lane

23/00655/FUL Renovation of existing derelict farmhouse and attached barn and dwelling, including the conversion of barn to living accommodation and single storey extensions at Lower House Fold Farm, Trigg Lane
